## **PARTICIPANTS RULES AND REGULATIONS**

1. All Entrants must abide to the following rules & regulations. Any false statement given will result in the disqualification of rights to participate in the 13<sup>th</sup> year of THE BEAUTY OF AFRICA INTERNATIONAL PAGEANT 2019.

### **2. QUALIFICATION**

- I. Shall be female, unmarried, never been with child and age between 17-26 years and must be at least 5ft "7" in height.
- ii. Must be of good health, good moral character, possess beauty of face and figure and with good personality.
3. The Organizer reserves the right to reject or accept any application received
4. The Judges decision in all matters is final and no correspondences will be entertained.
5. The organizers shall be the sole authority for interpretation of these rules and regulations. Decision of the organization is final and binding.
6. In the event that any participants or winners are unable to fulfill her commitment and comply with the rules and regulation, the organizers shall have the absolute right to disqualify the said participants as a candidate or winners and she will be asked to leave the camp where the contest is held voluntarily and immediately.
7. The organizer shall not be responsible for any monies and valuable belongings lost by the contestant during the pageant.
8. The organizer shall not be held liable in any incidents occurred to the contestant during the pageant.
9. The organizer reserves the rights to reject or replace any participant of the Beauty of Africa International Pageant 2019 in the event of the disqualification or the release from participation of such finalist application.
10. In the event of any winners are unable to fulfill her commitment with regards to the rules and regulations of the pageant and also fail to sign the winners contract agreement, The Organizer reserves the right to withdraw her title and claim back all prizes won and re-confer the award to the first or second runner-up.

### **11. CONTESTANTS MUST COMPLY WITH THE FOLLOWING**

- i. To arrive in camp for the contest held from 21<sup>st</sup> September, 2019 and coronation final will be held on 4<sup>th</sup> October, 2019. Departure 5th October, 2019.
- ii. To conduct herself properly during the period from her arrival in camp to the time of her departure after the contest.
- iii. Willing to obey and comply at all times during the period of the pageant and to attend all functions as requested by the Organizer and shall not be excused from such non –attendance except prior written consent to the organizer.
- iv. To allow and permit the organizer the exclusive right to use all photographs of the contestant and also for promotion. In this event, photographs of the contestants are not returnable.
- v. To travel with the organizer's promotion crew on fashion assignment, visit to charitable organization etc.
- vi. To appear on television, radio, fashion shows or any media for the purpose of publicity and promotion of the contest.

- vii. Not to accept any private engagement during the period of the contest.
- viii. To attend rehearsals promptly when requested by the organizer.
- ix. To be equipped with sufficient funds to cover incidental expenses.
- x. In the event that she is a winner or runner-up, she is required to stay for a few additional days in the state where the finals is held for post pageant activities, such as personal appearances, modeling or commercial advertisement and the like as required.

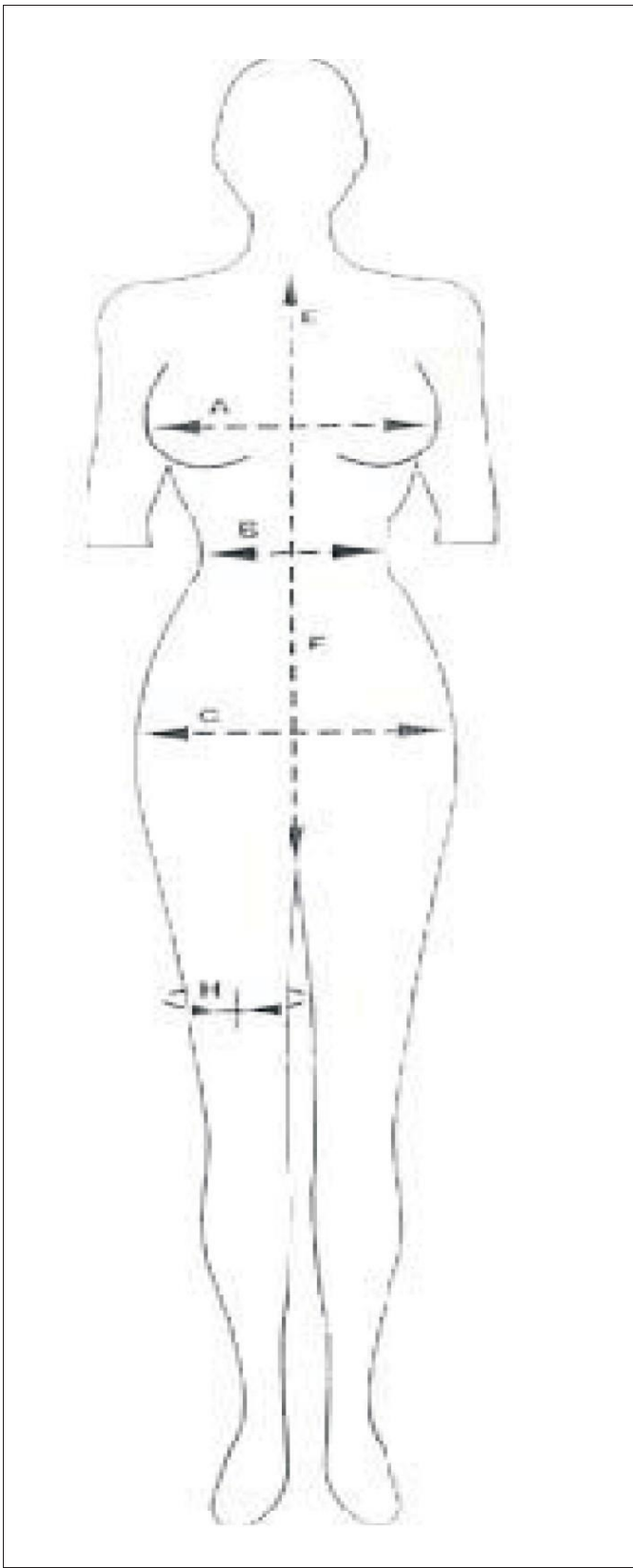

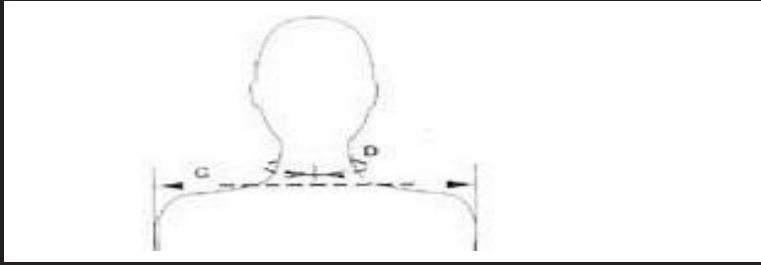
